

Women Lawyers Association of Michigan President's Report

I am pleased to report that our 95th Annual Meeting raised over \$23,000.00 in revenue, \$18,000.00 over the originally budgeted amount. We had over 125 people attend the meeting and our feedback was very positive. It was a shining moment in our history and set us on the path to our 100th Anniversary. During my year as President, we have continued to work toward improving relations between the State and Regions. Our first steps in our 5-year plan were marked by pleasant surprises. Increased communications helped us recognize how much we share and to focus on working together to achieve our goals.

We also focused on our relationship with the WLAM Foundation. The 5-year plan planning session was graciously paid for by the foundation who is a strong supporter of WLAM's efforts to work together as a cohesive group to achieve the goals of our mission statement. Our November meeting was a positive step forward as we devoted significant time to reconnect. Thank you Dawn Van Hoek and Paula Talarico for your attendance and presentation!

We took numerous steps to support women judicial candidates, writing letters of support, not necessarily of any specific candidate, but to point out the gender disparities in the judiciary, especially in the federal judiciary. Letters were written at the state and federal level and this year we celebrate that three additional female judges to the Federal Judiciary.

Hopefully you have noticed that WLAM has been sending e-mail communications when high level judicial positions become available like Bankruptcy Trustee, Magistrate Judge and U.S. Attorney General positions, to ensure that we give our members the best opportunity to apply and be considered for these positions.

WLAM also issued a position statement about the State Bar of Michigan, pointing out the SBM programs that support women in the legal process, and supporting its continuation in its present form.

And at our March board meeting before the Annual Meeting, WLAM voted to create a task force to work with the Lawyers' and Judges' Assistance Program to create a program to help lawyers who are dealing with domestic violence. It is the hope that a program such as this will help prevent future tragedies such as the tragic loss of attorney Lara Stutz.

All in all, it was a productive year for WLAM and it was a pleasure serving as your President during this time!

2013 Statement of Operations

- 1. Dues Revenue WLAM dues revenue declined in 2013 (\$43,707 in 2013; \$45,620 in 2012) but exceeded budget expectations (2013 Dues Revenue budget \$41,720; Actual revenues \$1,987.50 more than budget.) The 2013 Budget anticipated a decline due to the economic climate in Michigan.
- 2. Annual Meeting Revenue WLAM's 2013 Annual Meeting exceeded budget expectations and generated \$8,083.59 in net revenue. The original 2013 budget projected net revenue was \$4,077 (\$10,575 projected income; \$6,498 projected expense).

- 3. Dues paid to Regions The 2013 budget estimated dues to regions in the amount of\$ 10,430. Actual dues paid to regions in 2013 totaled \$11,082.50 (\$652.50 more than budget projections.)
- 4. Communications and Marketing. WLAM Board of Directors selected a no-cost broadcast e-mail service to communicate with members, eliminating the cost previously contained in line 750.30.
- 5. Line Item 820 Bank Fees is significantly less than budget due to an adjustment in credit card terminal charges. Fees in 2014 are expected to return to approximately \$1,760.
- 6. Net Income after expenses for 2013 was \$12,287.29, \$1,389.16 higher than 2012 (\$10,898.13.)

WLAM seeks to provide the following membership benefits in 2013-2014:

- A state-wide sponsored event;
- Budgeted upgrades for our communications and technology, with plans for the addition of an online member directory.

Procedural Improvements

WLAM's administrator continues to provide monthly Statements of Operations that compare actual year-to-date finances with our budget as of that date. We can quickly ascertain if we are on target with expectations. WLAM provides timely requests for information from regional leaders, so that regional financial reports are accurate and dues payments to the regions are prompt.

Women Lawyers Association of Michigan Annual Report of the WLAM Foundation April 2014

The WLAM Foundation enjoyed another very successful year of supporting women's education, raising over \$38,000 for scholarships. In 2014, the WLAM Foundation reached the landmark of \$500,000 given away in scholarships over the past eighteen years, to 210 awardees! The success of the Foundation is largely based on the exceptional talent of its Board of Directors, comprised in 2013-14 of Dawn Van Hoek (Chair), Paula M. Talarico (Treasurer), Sandra L. Sorini (Secretary), Lori D. Becker, Z. Kay Fitzpatrick, Nancy Glen, Markeisha Miner, Deborah K. Nowak-Vanderhoef, Meghan Kennedy Riordan, and Maya Watson.

Fundraising in 2013-14 took the forms of event sponsorship (\$1,250), the Sixth Annual Culinary Challenge (\$5,630), the "Dean's List" giving campaign (approx. \$28,225), dues check-off from WLAM members (\$800) and the Kimberly M. Cahill Fund (\$3,600). Major continuing support was shown by corporations and law firms, particularly General Motors, the Albert & Doris Pitt Foundation, the Dickinson Wright Women's Network, Bodman PLC, Carole Chiamp, Judge Pamela Harwood, Kerr, Russell and Weber PLC Fund, Marianne and Judge Lawrence Talon, and the Culinary Challenge Committee. 




