WLAM ANNUAL REPORT 2014-2015

The 2014-2015 year was a very busy year for the Women Lawyers Association of Michigan (WLAM). This past year was the first year of a five-year plan developed by an advisory committee of WLAM past presidents. The WLAM 5-year plan is ambitious, but it is my firm belief that it will lead us into our 100th year anniversary as a larger, stronger, and more cohesive organization.

Some of the strategic goals met in Year 1, include:

Successful WLAM Programming:

- Annual Meeting at the Bavarian Inn Lodge, Frankenmuth, Michigan, exceeded budgeted revenue expectations and featured the following breakout sessions:

- Hosted showing of the film "Girl Rising" a groundbreaking film seen by millions and part of a
 movement for girls' education that shows how educating girls can change the world for the
 benefit of the WLAM Foundation and Enough Said.
- o Hosted MsJD viewing event in Detroit, featuring Paulette Brown, the first African American woman to be elected as the American Bar Association President.
- o Implemented a new WLAM webinar series.
- o Collaborated with many organizations to host various events, including:
 - Our Diverse Bar
 - The Power of Us (with the National Association of Women Lawyers)
 - Equal Pay Day Rally at the Capital (Lansing, Michigan)
- o Provided WLAM members with information regarding pro bono opportunities, referrals, judicial openings and information regarding free webinars.
- **Increased Advocacy**: This year WLAM advocated for equal protection under the equal protection clause, to various circuit courts and to the U.S. Supreme Court via amicus briefs.

• Increased WLAM's Digital Presence:

- o Reworked our existing LinkedIn presence and established new State WLAM Social Media
- Updated the WLAM website to be user-friendly and implemented strategic meta tags to increase search visibility. The new WLAM website also now features:
 - A referral directory (for use by the public and for member to member referrals)
 - A WLAM members-only section (for resources and member-to-member communication)
 - Recognition of Past Presidents and WLAM Award Recipients
 - Integration of WLAM state and regional social media, as well as statewide communication
 - Improved state-wide calendar and established individualized regional calendars

2014 Statement of Operations

- 1. **Dues Revenue** WLAM dues revenue declined in 2014 (\$40,780 in 2014; \$43,707 in 2013). The budgeted amount for 2014 was \$43,720 which was an increase in the budget from 2013 by \$2,000. Dues are anticipated to increase with membership with the implementation of the strategic plan by WLAM.
- 2. **Annual Meeting Revenue** WLAM's 2014 Annual Meeting exceeded budget expectations and generated \$11,700 in revenue. The original 2014 budget projected revenue was \$9,725. The actual expense of the 2014 annual meeting was under budget by \$885.32 (\$4,200 was projected expense; \$3,314.68 actual expense). The net income from the annual meeting was \$8,385.32 which gave the organization a gain of \$2,860.32 over budget.

- 3. **Dues paid to Regions** The 2014 budget estimated dues to regions in the amount of \$12,500. Actual dues paid to regions in 2014 totaled \$12,183.75 (\$316.25 under budget projections.)
- 4. **Communications and Marketing**. WLAM Board of Directors selected a no-cost broadcast e-mail service to communicate with members, eliminating the cost previously contained in line 750.30.
- 5. **Line Item 820 Bank Fees** relates to credit card terminal rates. Fees in 2014 were budgeted at \$1,760. The actual fees were \$1,923.18. The \$163.18 over budget expenses can be attributed to the increase in credit card usage by members.
- 6. Net Income after expenses for 2014 was \$3,153.25 which was \$3,115.25 over budget.

WLAM provided the following membership benefits in 2014-2015:

- A state-wide sponsored event with the showing of "Girl Rising" and fundraised for WLAM-Foundation which provides scholarships
- WLAM website was redesigned and launched
- Updated WLAM logo and marketing materials
- Webinar provided to members on Federal judiciary appointment process
- WLAM provided support of amicus briefs on policy issues
- WLAM launched the member of the month program
- WLAM participated in Equal Pay Day events on April 14th in Lansing
- WLAM provided ABA tips for young lawyers
- WLAM implemented the 5-year strategic plan announced at the 2014 annual meeting

Procedural Improvements

WLAM's administrator continues to provide monthly Statements of Operations that compare actual year-to-date finances with our budget as of that date. We can quickly ascertain if we are on target with expectations. WLAM provides timely requests for information from regional leaders, so that regional financial reports are accurate and dues payments to the regions are prompt.

This committee develops programs and services to: (1) assist members in dealing with gender bias; (2) raise awareness among the bench, bar, law schools, law enforcement, state government and/or general public of the continuing problem of gender bias; and (3) attempts to reduce the frequency and severity of the incidents and effects of gender bias on individual lawyers and members of society.

WLAM was a co-sponsor in 2015 with several other organizations of Equal Pay Day events in Lansing on April 14, 2015. Equal Pay Day originated in Michigan in 1996 as a public awareness event to illustrate the gap between men's and women's wages. It is held on April 14th to symbolize how far into 2015 women must work to earn what men earned in 2014.

WLAM participated in an Equal Pay Day Rally on April 14 in the Rotunda of the State Capitol Building. Members also attended a pay equity briefing beforehand.

In 2013-2014 there were eight measures to promote pay equity introduced in the Michigan Senate and House. There was never action taken on those bills. They were reintroduced in April of 2015. The bills include:

- HB 4516 (Lamonte), SB 297 (Young) requires employers to supply certain wage information upon request
- HB 4517 (Slavens), SB 296 (Warren) establishes a pay equity commission
- HB 4518 (Driskoll), SB 299 (Whitmer) prohibits wage discrimination
- HB 4519 (Hovey-Wright), SB 298 (Warren) provides penalties for wage discrimination

The Women Lawyers Association of Michigan Foundation enjoyed another very successful year of supporting women's education, raising over \$42,000 for scholarships. In 2015, the WLAM Foundation reached the level of \$530,000 given away in scholarships over the past nineteen years, to 220 awardees! 



I. 2014 Membership Events
