Annual Report of the WLAM Foundation May, 2000

The WLAM Foundation completed another very successful year, building on the groundwork of prior years. It raised more money through a combination of innovative campaigns, awarded more money to deserving women law students, continued support for the "mother" WLAM, and assumed a higher profile among the state's bar-related foundations. Accomplishment of these goals was due to the exceptional efforts of a talented board comprised of Dawn Van Hoek (Chair), Kimberly M. Cahill (Treasurer), Sandra L. Sorini (Secretary), Mary Barden, Z. Kay Fitzpatrick, Deborah R. Garcia-Luna, Jennifer T. Gilhool, Nancy Glen, Michelle D. Johnson, Loretta Lewins-Peck, Linda Fowler-Sims, and Paula Talarico.

Fundraising continued in the form of a WLAM membership "dues check-off" which gave WLAM members an option of adding a contribution. Dues check-offs and direct contributions raised over \$1,300 (through 3-31-00). In addition, the Foundation continued its theme of "Art for Attorneys" at an art sale hosted by the Detroit law office of Dykema Gossett. With the generous help of the firm and Peggy Costello, cosponsorship by the WLAM Wayne Region, help of Nancy Glen and participation of three artists (including WLAM member Barbara Wynder), the Foundation raised approximately \$1,000 at the March 2nd event. The March art fundraiser followed a smaller event at the home of Foundation Trustee Nancy Glen, including the art works created last year by the Foundation's attorney-artists.

The Foundation also continued its "Dean's List" campaign, designed to build on the commitment shown last year by the Ford Motor Company, the Howard & Howard Community Reinvestment Fund, and other firms. Intended to directly support scholarships, the campaign was joined by law firms and corporations contributing at various levels: summa cum laude (\$2,500), magna cum laude (\$1,000), and cum laude (\$750). The results of the year-2000 Dean's List Campaign will be announced at the Annual Outstanding Women Law Student Reception, taking place this year on May 12, 2000 as part of WLAM's Women and the Law Conference. A special program that day will feature recognition of the Dean's List contributors, and announcement of the recipients of this year's law student scholarships. Due to the success of last year's fundraising efforts, scholarship amounts were continued at \$1,250 for each student at four schools, and \$2,500 for the University of Detroit Mercy student, awarded by the Howard & Howard Community Reinvestment Fund. The year-2000 awardees are: Paula Gentius-Harris (University of Detroit Mercy), Sarah DeYoung (University of Michigan), Angela K. Sherigan (Cooley), Ann Marie Byers (DCL at MSU), and Sarah Pring (Wayne State).

The Foundation also awarded \$1,000 to the state Women Lawyers Association of Michigan, earmarking the contribution for the Women and the Law Conference.
