Dear WLAM Members,

This year's theme for the Women Lawyer's Association of Michigan was GRIT. Grit is, by definition, "courage and resolve." Grit is also made up of five characteristics – courage, conscientiousness, perseverance, passion, and resilience. I could not think of a better theme for a year that continued with challenges as we entered a "new normal." Our work within WLAM does not operate in a vacuum, but in the context of the events going on in our society – including the ongoing Pandemic, racial and ethnic dissension, and political divides. Our organization demonstrated our resilience, courage, conscientiousness, perseverance and passion.

After our annual meeting we swore in our board – in person – and on the steps of the Michigan Supreme Court, on May 23, 2022. We were honored to have Justice Elizabeth Clement swear us in, and for those not able to join in person – logged in via ZOOM. Afterwards our group enjoyed a relaxing and reconnecting brunch.

We kicked off our year with our Annual Meeting in a hybrid fashion on June 4, 2022, the theme being Grit. We welcomed renowned speaker, Milana Hogan, author of "Grit, The Secret to Advancement: Stories of Successful Women Lawyers." Members from around the state gathered in small groups, while others joined from home through ZOOM. Members completed the Grit Screening Tool in advance of the meeting, and broke into small groups to discuss different scenarios and how to use the grit toolbox to handle.. Attendees received purple WLAM themed grit masks and a copy of Ms. Hogan's book.

2022 Statement of Operations

- 1. Revenue from Member Dues: Dues revenue for the year was \$49,512. Dues revenue for the last five years has been \$49,521 in 2020, \$50,977 in 2019, \$45,669 in 2018, \$44,055 in 2017, and \$42,255 in 2016.
- 2. Revenue from Annual Meeting: For the second time WLAM held its annual meeting virtually. The net profit for the meeting was \$1,301.28.
- 3. Dues Paid to Regions: Dues paid to regions totaled \$13,831.75 in 2021.
- 4. Other Extraordinary Expenses in 2021: Aside from the cost of books and masks given to attendees of the annual meeting and dues paid to regions, expenses were as either essentially anticipated or less than anticipated in 2021.
- 5. Special Sponsorships: As in years past, we continued to support the regions by offering special project funding. The regions utilized \$1,900 of the \$2,500 available to them.
- 6. Total Net Revenue: Unfortunately, the pandemic continued to curtail our ability to raise revenue through sponsorships. Thus for the first time in years, the Board voted to raise the rates of WLAM's membership dues to maintain the financial health of the organization. The net revenue for the year was \$740.67.



Women Lawyers Association of Michigan Leadership Class Committee Annual Report 2021-2022

The WLAM Leadership Class is a WLAM initiative created to further its mission of securing the rights of women in society, advancing the interests of women members of the legal profession, promoting improvements in the administration of justice, and promoting equality and social justice for all people. The Leadership Class is an inclusive program available to all law students, regardless of their gender, race, national origin, ethnicity, sex, sexual orientation, political affiliation, or any other inalienable trait. While the Leadership Class is designed to further the WLAM mission, we always have been, and will remain, an inclusive organization.

The Leadership Class benefits law students by providing students with the tools to develop the professional skills necessary for success and leadership positions in law, business, government, the nonprofit sector, and the judiciary. Participation in the Leadership Class greatly enhances participants' business contacts, equips them with the tools necessary for professional development, and provides opportunities that typically do not exist without this program.

In order to be eligible, Class Participants must:

- 1. Be currently enrolled in law school,
- 2. Attend a Michigan law school or provide a demonstrated commitment to work in the legal profession in Michigan during the upcoming summer,
- 3. Complete the WLAM Leadership Class Application located here, which includes providing the following:
 - a. Resume,
 - b. Photo,
 - c. Statement about leadership describing the following:
 - i. What leadership means to you;
 - ii. Why you wish to participate in this Leadership Class; and
 - iii. How you expect to use your experience in this program.
 - d. Letter of recommendation.

In addition, by applying for the WLAM Leadership Class, applicants commit to the dates as stated in the WLAM Leadership Class Curriculum.

Class Participants are chosen based on their demonstrated commitment to elevating the standing of women in the legal profession. WLAM may select up to ten (10) applicants, or however many as it deems necessary, to join its WLAM Leadership Class.

For 2021, the Leadership Class was held virtually, with the exception of the Graduation and Project Presentation, that we held during our September 2021 Board Meeting at Warner Norcross. The Curriculum was similar to the one listed below. We had a total of nine participants. For 2022, we have selected a total of fourteen participants.

The WLAM Leadership Class Curriculum is as follows:

Leadership Class Retreat - May 21, 2022

This day-long Retreat features various sessions designed to develop students' leadership skills. Class Participants will also begin the initial groundwork on a group community service project. The seminar is

followed by a mixer so that the students can become better acquainted with each other, program faculty, and class facilitators. The Retreat will feature the following:

- Introduction and Ice Breaker
- Overcoming Obstacles in the Legal Profession Fireside Chat
- DISC Assessment and Presentation
- The Importance of Diversity, Equity, and Inclusion in Leadership
- Screening of the WLAM Documentary and History about WLAM
- Panel Presentation on Setting Yourself Up for Success
- Tips and Tricks of Effective Leadership from Program Facilitators and Past Class Participants
- Leadership Class Project Planning
- Happy Hour for the Class Participants to get acquainted with one another and Program Facilitators

Speed Networking Event – Judges and Experienced Attorneys – June 22, 2022

In advance of the event, students will receive instruction on how to network. At the speed networking event, students will have the opportunity to have one-on-one meetings lasting approximately seven (7) to ten (10) minutes with the participating judges and experienced attorneys.

Book Club - July 20, 2022

At the start of the class, the class participants will receive a leadership book selected by the class facilitators. Near the end of the summer, the Class Participants participate in a guided discussion of the book. The book selection for this year will be *Huddle* by Brooke Baldwin.

WLAM Leadership Class Cocktail Hour – August 3, 2022

This Cocktail Hour will be an open invitation to the Class Participants to come and network in an informal setting with each other and fellow women attorneys in the legal community. The Class Participants will be able to put the skills they learned from the Speed Networking event to use.

Graduation and Project Presentation – August 17, 2022

Class Participants will have the opportunity to network in a more traditional setting with WLAM Board members. The class participants will present their project to the WLAM Board members present. The class participants will then graduate from the class.

<u>Community Service Project – Ongoing</u>

The Class Participants will select, organize, and execute a self-directed community service project aimed at elevating the standing of women in the legal profession. The 2021 Leadership Class developed tool kits for getting into law school and having success in law school for students in high school, college, and law school. The project shall be completed and able to be presented at the Graduation as stated above.

Below is the Timeline that the Leadership Class Committee has followed to implement the 2022 Leadership Class. The Committee plans to follow and update this Timeline each year, as necessary, and based on feedback from the end of the year survey:

October	Retrieve feedback from previous Class via a survey.

November	 Start preparation and/or revisions to the application, including all the eligibility
	requirements for each participant and the required documentation to include in the

	 Reevaluate and/or create the Curriculum for the next Leadership Class. Send out a Save The Date to the membership stating that the applications will be available starting January 1, 2022.
December	 Create/reevaluate the sponsorship opportunities available for the Leadership Class. Start planning the sponsorships we plan to solicit. Continue to advertise for launch of the Class Application.
January	 Applications open on January 1, 2022. Begin reaching out to law schools to have them advertise for the Leadership Class. Start asking all identified sponsors identified for sponsorships and continue until May.
February	 Host two Virtual Open Houses about WLAM Leadership Class first week of February with the law schools. Begin planning the Board Retreat, including requesting speaker's participation.
March	 Advertise on social media and to our membership via email that the application deadline is March 10, 2022, and extended to March 25, 2022.
April	 Select Class Participants by first week of April and send a notification letter to all Class Participants.
May	 Host the Board Retreat – May 21, 2022 – Organized by the Committee Class Participants begin working on Class Project, which continues throughout.
June	Host Speed Networking – June 22, 2022 – Organized by Essence Patterson
July	Host Book Club – July 20, 2022 – Virtual – Organized by Nicole Smithson
August	 Graduation and Project Presentation – August 17, 2022 – Organized by Kirsten Silwanowicz and Tanya Grillo



At the meeting, the board collaborated on various ideas and plans. The events


included the Komen More Than Pink Walk on October 17th, with WLAM Mid-Michigan having their own team along with partnering with MSU Law Women's Law Caucus.



The **Tip of the Mitt Region** endured the pandemic with **GRIT** and maintained a roster of 24 members throughout the course of the year!


The 2021-2022 Tip of the Mitt Region of WLAM Board Members were sworn in on June 9, 2021. The elected Board was composed of the following Directors:








WINE, DINE, AND PUMPKIN PAINTING




Black History Month 2022 February 1, 2022 – March 1, 2022

Wine and Garden Party



WLAM Wayne conducted a donation drive for Menstrual Hygiene Products for the month of February. We raised over \$1,000.


